## DECREE

### *Declaration of Boundaries for a Parish*

I, the undersigned Bishop of Jefferson City, hereby state the following in regard to the parish of

St. Anthony, Rosati:

*Whereas*, the formal decree establishing the parochial territory of this parish no longer exists, and there is a need to provide for an orderly record of the boundaries of this parish; and

*Whereas*, having received the proposal of the former Rolla Deanery on the boundaries of this parish, and after consultation with the Presbyteral Council on 9 February 2021 in accordance with canon 515 §2;

*Therefore*, by this DECREE, I hereby declare that the territory of this parish shall be bounded by the following:

North – From the intersection of Hwy B and the north Phelps Co. line following the county line east to Crawford Co. and continuing along the Crawford Co. line north then east to a point halfway to the intersection of Hwy 19.

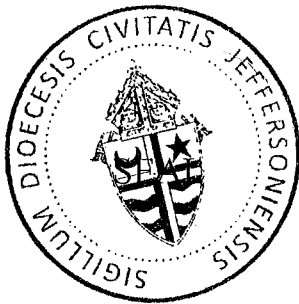
South – The Meramec River to the intersection of the Phelps Co. line.

East – From a point on the northern Crawford Co. line halfway between the northwest corner and the intersection of Hwy 19 following an imaginary line due south to the Meramec River.

West – From the intersection of the Meramec River and the Phelps Co. line following an imaginary line northwest to the intersection of Co.Rd. 1140 and Hwy B and continuing on Hwy B north to the county line.

All things to the contrary notwithstanding.
